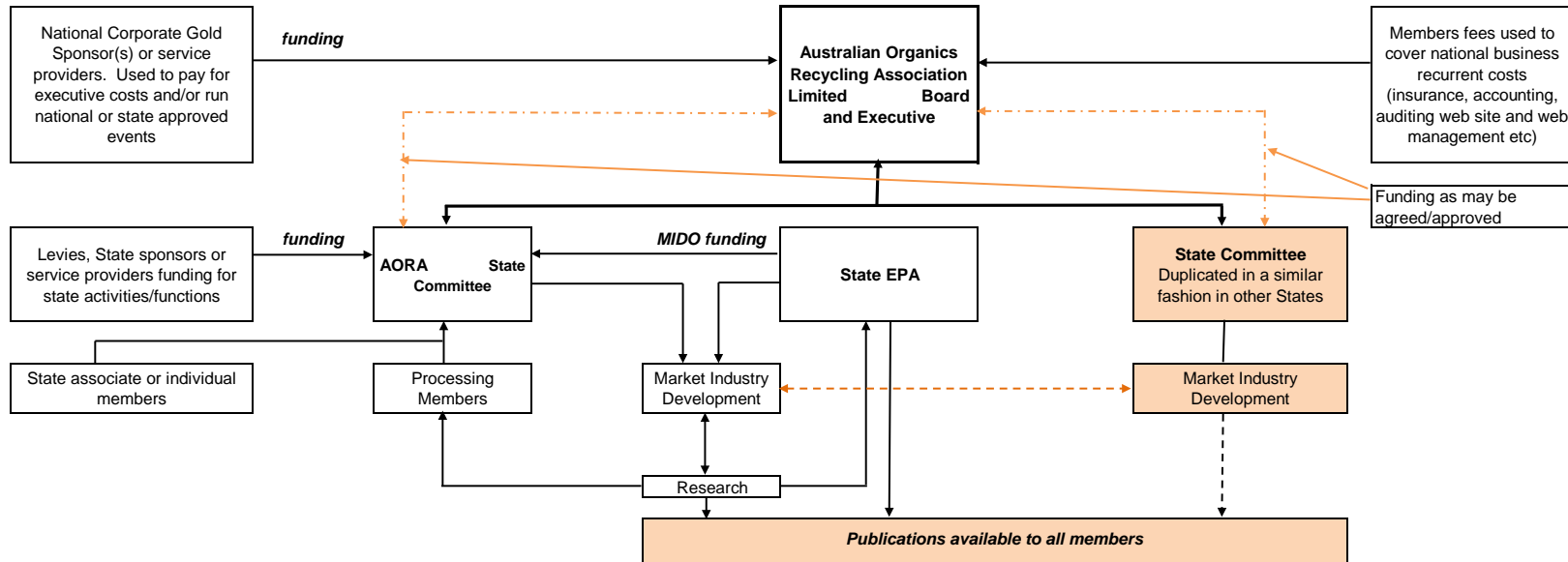
AORA Member's Logo
