

# **AORA CHAIR'S REPORT**

On the proceedings of the Company 2022-23, as presented at the Annual General Meeting on 17 November 2023.

AORA, led by our National Executive Officer, John McKew, has continued to make great strides in the organics recycling industry and I would like to thank John for his hard work across the year, and particularly in helping AORA to raise its profile and be part of many conversations at Government level.

Out National Coordinator, Alex Hammett continues to ensure that AORA and all it's elements run smoothly across the country, with the support of our Victorian Coordinator, Doug Wilson and New South Wales Coordinator, Lisa Lepore.We had to make the difficult decision in December 2022 to cease the contract of our South Australian Coordinator, Yvonne McLaren due to financial position of membership in that state.



I also extend our thanks to Lisa Dower from Dower House Bookkeeping and Veronica Dullens and her team at Revolve Services, their input is invaluable and we continue to enjoy working with them.

I thank the Board for its ongoing commitment and our Members and sponsors for their strong support.

It was great to get back to normal in 2022- 23 with AORA events taking place across the country. The AORA conference, held in June 2023, in Melbourne was the highlight of the year, with 26% growth in audience since the previous conference. With 319 delegates attending from across the country to discuss the strong and robust collaboration between Australia's organics recycling industry, State and Federal governments and businesses, and the implications of Australia "getting organics recycling right" by leveraging improved collaboration and cooperation. We had strong involvement from sponsors and exhibitors at the Demonstration Day and Exhibition elements, with 26 pieces of equipment onsite at RePurpose It.

# **AORA CHAIR'S REPORT CONTINUED**

The second edition of the Economic Contribution of the Australian Organics Recycling Industry report was presented with some interesting findings;

- In 2021-22, Australia produced 14.8 million tonnes of organic waste of which 5.4 million tonnes was sent to landfill, 7.7 million was recycled and 1.6 million tonnes recovered through energy, this was a 1.4 per cent increase on recycling, compared to the previous financial year.
- Australia's overall organic material recycling rate in 2021-22, was 52.3% equating to 296 kg/person of recycled organic material for each person in Australia. SA leads the way in recycling 725kg/person, followed by the ACT recycling 644kg/person each year.

One of the biggest challenges to our industry and a very real danger at the moment, is that the Australian organics recycling industry is being unreasonably held to account for the extremely low levels of forever chemicals that may be detected in our products – compost, mulches, and soil conditioners. These chemicals include the broad category referred to as PFAS, which are found in every Australian household in products used in everyday life including food packaging, carpets, lipstick, mascara, dust, firefighting foam, and many more.

It is really important to put PFAS concentrations in compost into a real-world context - both for the general public and for regulators. PFAS is found everywhere and in everything, that is not in dispute. It is also (and this is really important) not made as a consequence of the composting process nor is it an additive to the process. PFAS contamination occurs in trace levels within compost as a result of it being present in the feedstocks that are used to make compost – food scraps, etc. With PFAS literally everywhere, there is no way to avoid it being found in trace levels in finished compost products – levels much lower than the levels found in day-to-day products we all use in our homes. Restricting the use of PFAS is the only way to reduce its presence in our waste streams.

Over-regulating PFAS levels within compost is almost absurd. Some Australian jurisdictions are contemplating allowable levels of PFAS in compost as low as one part per billion (1 ppb), which is not possible. This is conceivably much lower levels than currently exist within our own bodies and certainly within many of the products we regularly use.

AORA has a very pragmatic and rational view about the PFAS issue: restrict or ban the use of the compound - don't over-regulate the Australian organics recycling industry with regards to PFAS as the adverse consequences of this will be detrimental and far-reaching including increased volumes of food and organic waste streams returning to landfill which directly contradicts our federal and state government objectives of reaching our net zero emissions targets. If we want a successful circular economy and the benefits this can bring, economically and environmentally, we must have a robust, sustainable, and commercially viable organics recycling industry and we cannot allow over-zealous regulation to prevent that.

This is my final Chairman's report, as I am retiring as the Chair of AORA at the 2023 AGM, it has been an absolute pleasure to lead this organisation and I thank all of the AORA Staff, Directors, Partners and Members for their support over the years. In my time in the organics recycling industry I have seen great change, and I know there is significantly more to come, and I am hopeful for the next generation who will lead the industry.

# AORA NATIONAL EXECUTIVE OFFICER'S REPORT

Reflecting on my first twelve months as the National Executive Officer for AORA, I am conscious of not sounding too trite but if there is one word that comes to mind to sum up my first year, it would have to be challenging.

Personally, entering a new industry and leading a new organisation will naturally be challenging and that is to be expected and my focus had to be on building an understanding quickly of the immediate challenges internally and externally. Whilst I feel I have a good appreciation of the internal challenges, externally, the industry is shifting quickly and the forces impacting the Australian organics recycling industry change rapidly.



Internally, the initial focus of my tenure was on rebuilding a sound financial position for AORA. We have achieved the first stage of that financial rebuild by posting a modest surplus this year. From here we need to continue to consolidate the balance sheet and ensure we can continue to secure a long-term, sustainable financial position for the Association. That translates to more members and more sponsors (and less attrition of both) and wherever possible, availing ourselves of government grants to prosecute our work program. To attract more members and correspondingly, more sponsors (I believe sponsors are easier to attract when you have a strong and loyal membership base), you need to have a strong value proposition and associated delivery of programs – something that speaks to members that states it is in their very best interest to be involved in the Association – it is not a question just of value, it is a question of need. Value propositions change and evolve over time and that applies to AORA also and a key component of that is a strategic plan.

The current AORA strategic plan concludes at the end of 2023 and the AORA Board asked me to review the existing plan and develop a new plan, which has now been completed. The new strategic plan is not a significant departure from the previous version, it is a refresh and refocus. From my NEO perspective, a key focus of our new strategy has to be on communications. In my previous CEO roles, there has been a strong correlation to improved Association outcomes (i.e., member satisfaction) when we have improved our communication efforts. We do a very good job on social media and with our newsletter, but I think there is room for improvement, especially with the media and with other key stakeholders, especially governments. More broadly however, the strategic focus areas for AORA can be ascribed across five zones: Advocate / Communicate / Educate / Collaborate / Innovate. These are not mutually exclusive but work in partnership with one another to deliver optimal outcomes.

Externally, there is a long list of challenges that we are aware of, and I am sure many more that are yet to materialise. Contamination is obvious and when we dig deeper into that, we are confronted with PFAS, microplastics, etc. AORA has been active this year in establishing our concerns and position of PFAS and through strong cooperation with our processing members, we were able to make a strong submission to the PFAS NEMP 3 with the assistance of Dr Matthew Askeland. We will continue to make strong representation on key issues that will impact on our industry, and we will state our position in an authoritative, balanced, and credible manner.

Our external relationships also require time and attention and probably more of it. That certainly includes governments, but it also includes other stakeholders that we have a reciprocal stake of mutual interest with. Of note in the last year has been the establishment of an MoU with ACOR (Australian Council of Recyclers). Increasingly ACOR and AORA are working on joint positions on issues, and we feel this united voice will only bring stronger recognition and appreciation for our industry and the broader recycling sector. We continue to seek out and support other initiatives, including various CRC's (e.g., Fight Food Waste CRC, Soil CRC); more recently we have been assisting the Solving Plastic Waste CRC with their renewed bid for CRC establishment and funding.

In concluding my AORA NEO Annual Report for 2023, I would like to acknowledge and thank the AORA Board for their support and guidance. I am also extremely thankful for the outstanding support and dedication from Alex Hammett, our National Coordinator. In addition to her current and considerable AORA work program, Alex took on the role of SA State Coordinator in 2023. Nothing ever seems to daunt Alex and her work ethic on behalf of AORA is outstanding. I would also thank and acknowledge the excellent efforts of Lisa Lepore, our NSW State Coordinator. Lisa brings significant passion and conviction to her role on behalf of AORA and the organics recycling industry in NSW.

I also acknowledge and sincerely thank Lisa Dower for all of her efforts and hard work in managing our accounts and finances and Veronica Dullens and her team at rEvolve Services (especially Emma McVie) for planning, coordinating, and executing the AORA Annual Conference. The AORA Annual Conference is no easy task and whilst there is a Conference Committee to guide and assist, the work on the ground happens because of Veronica and Emma. 2023 was AORA's biggest and most successful conference ever and that is largely the result of the investment of time and effort by Veronica and Emma. We aim to make 2024 bigger and better again and hope that you will join us on the Gold Coast (5-7 June 2024) for the 2024 AORA National Conference.

# **AORA FINANCE REPORT 2022 - 2023**

A copy of the full (audited) AORA Financial report For the year ended 30 June 2023 is available to all members on request.

## The 2022/23 financial year delivered a surplus of \$36,890 for AORA.

This compares very favourably to the previous financial year loss of (\$188,304) but was below the budgeted surplus of \$56,697.

The key financial outcomes were:

#### Revenue and other Income: \$840,386

Income improved in 2022/23 compared to 2021/22 by \$324,630 due to increases in all major income streams including membership fees, sponsorship, projects and grants, conferences and events, and levy. 60% of income is derived from the top 4% of Income types as indicated in the table.

From an aggregate perspective of Total Income, Membership accounts for 20%, Events 41% and Other income (including levy) 39%.

## **Expenses:** \$803,496

Expenses increased by \$99,436 in 2022/23 compared to 2021/22. Increased Admin Support Costs, Conference and Events Expenses and Other Operating Expenses all contributed to this result. 61% of expenses is derived from the top 4% of Expense types as indicated in the table below.

From an aggregate perspective of Total Expenses, Events & Projects accounts for 40%, Employment 22%, Office & Administration 32%, Promotional 5% and Other expenses 1%.

## Surplus: \$36,890

The financial surplus of \$36,890 for the 2022/23 year is a significant and important improvement on the reported loss of (\$188,304) for the 2021/22 year and accounts for a \$225,194 turnaround. Whilst this is pleasing, the result was not possible without making some difficult decisions, namely the cessation of the contract for our SA State Coordinator at the end of March 2023 and a reduction in contracted hours for our VIC State Coordinator at the same time. Considered and careful scrutiny of all expenses have also contributed to the result including but not limited to travel.

There should be no surprise that the focus on the Association's financial position moving through the 2022/24 year has to be on income, especially growing the membership, levy, and sponsorship base. There is no substitute for a loyal, robust, and growing membership and sponsorship base for any Association, including AORA.

Expenses will also be carefully monitored and controlled, especially in an environment of increasing CPI and general increases in most business-related costs. The Board and NEO are mindful that we have to invest in the business to improve productivity and the servicing of our members and sponsors and that is why we will have invested in a new integrated website and member database (i.e., CRM) system to be implemented in early 2024. Our current systems, especially our CRM, are inadequate and productively draining on the Association. We are also actively recruiting a new VIC/TAS State Coordinator and a WA State Coordinator.


